St Giles Kirk Session Report 2019

Surveying the events of 2019, one is struck and somewhat humbled by the grace and good fortune of our little congregation in the past year.

We started the year with what can only be described, with no fault attached to our Search Committee or Interim Moderator the Rev. Philip Kim, as the collapse of our search process. Since then we have started the search process again. We were extremely fortunate to gain the leadership of our two Co-Interim Moderators the Rev. Dr Cedric Pettigrew and the Rev. James T. Hurd who have excelled in their respective roles Moderating the Search Committee and Session. Not to mention the leadership of our two convenors Bob Fourney and Don Tate, and clerk Kate Ferguson we have been able to build on the work of the last search committee. I am happy to report that we are nearing a successful conclusion in our search for a permanent Minister.

In 2019 we were extremely well served by Mr Hurd who since April had with great organizational skill found a great many Ministers and members of the order of Diaconal Ministers to provide supply every Sunday.

While we were grateful to all those supply ministers, thanks to the initiative and input of Don Tate, Rob Brandon and Bob Fourney, Session under Mr Hurd drafted a contract and I am happy to report that going into 2020 we have the good fortune to have Pastor Dan Reid as our regular supply minister for the first six months of the new year. In addition to being a sincere and compelling preacher Pastor Reid has already made great steps in expanding our community outreach. We are pleased as a Session to welcome him, his wife Melody, and their two children into our community.

Although we temporarily lost Patty Fraser from Session earlier in the year I am glad to say that she has rejoined us. Her great faith and sincerity have been as ever welcome and we are better functioning as a Session now that she has rejoined us.

I must report one loss this year, Willy McNaule. Although he had not attended many services in the last part of his life, he consistently volunteered at events and was always a welcome and cheery presence.

In 2019 we gained Sam and Miriam Banda who have transferred their membership from Grace Calgary, we are especially glad to welcome them as members once again.

One of the highlights for me this year was the visit of the Moderator of the 145th General Assembly, the Rev. Amanda Currie, who gave a talk at St Giles on Saturday, September 21. My thanks to her and the GA staff for the extremely courteous and punctual response to Session's invitation. The Rev. Currie's talk on Unity and the Scandal of Division was very well regarded by those in attendance.

In terms of thanks, to begin I would like to thank on behalf of Session, Mr Hurd for having taken a keen interest in our ongoing business, offering the benefit of his considerable experience and providing pastoral care

to our congregation.

In no particular order, I would like to offer on behalf of Session thanks to our Rental Coordinator Jean Currie, our faithful Church Administrator Patricia Brush, the Trustees, Roll Clerk and Centretown Churches Social Action Committee rep Stan Currie, the Women's Association for their fund-raising, our representative at the refugee committee FACCES, Jane Pope, the members of the Search Committee and Rob Brandon and the Finance and Maintenance Committee (F&M).

As always we are especially grateful to the choir and our music director Brenda Beckingham for their gift of music.

In terms of ongoing outreach, in 2019 St Giles gave \$6,100 to the Gracefield Christian Camp and Retreat Centre, \$5,329 to Presbyterians Sharing and \$3,263 to PWS&D.

Personally I continue to be impressed by this congregation's generosity and humbled.

It is my prayer that St Giles will not only continue in 2020 and the future but thrive.

Co-Interim Moderator (Search) and the Search Committee

The Search Committee entered 2019 with two possible candidates. Thus, two interviews were planned and executed. One took place in December 2018, and the other January 10, 2019. Following the interviews, the committee came to the point where they had to choose one candidate. Having considered the candidates' profiles, references, sermons, interviews, visits to the candidates' churches and their work in their home presbytery, the committee made their final decision.

The name of the candidate was presented to the session who, in turn, worked out details to bring this candidate to St Giles to preach for a call. Though the stipend and allowances were clearly described in the congregational profile, the candidate was not satisfied with the financial package as agreed upon by the session and presented in the profile. The session could not accept the candidate's counter-proposal. As a result, the candidate removed himself. The committee decided not to pursue the second candidate. As a result, the committee members determined that it was necessary to take a break before moving forward. Meantime, the Interim Moderator resigned citing increased activities in his church and family responsibilities.

No further action was taken by the Search Committee until the presbytery assigned another Interim Moderator. In September, the presbytery appointed the Rev. Dr Cedric Pettigrew to be a Co-Interim Moderator with the sole responsibility of working with the Search Committee.

The Search Committee was reconstituted in September 2019 with a change in membership. The committee is made up of the following members: Don Tate and Robert Fourney (co-conveners), Kate Ferguson (secretary), Rob Brandon, Jean Currie, Bodee Quansah, Isaac Ives and the Rev. Dr Cedric Pettigrew (Co-Interim Moderator).

Regular meetings were held starting in September to the end of the year. The committee reviewed its terms of reference, updated the congregational profile, and determined a timeline by which St Giles would be prepared to issue a call. The number of meetings was anticipated to increase in January to conduct interviews and receive any additional inquiries that might arrive.

The vacancy was reposted on the Presbyterian website and letters written to the principles of the Presbyterian College in Montreal and Knox College in Toronto. This produced a total of twelve inquiries. Further applications were sent from the National Office. After reviewing the applications, the Committee reduced the number to three who were invited for interviews early in 2020.

Following interviews, the Search Committee will determine which candidate is most suitable to fulfil the vision and future plans for St Giles as presented in the congregational profile.

Activity Reports

Cameron Highlanders of Ottawa (Duke of Edinburgh's Own)

In 2019, the Cameron Highlanders of Ottawa continued their active association with St Giles. They consider St Giles to be their regimental church. Don Tate represents St Giles at the Regimental Association meetings, maintaining an ongoing link with the Regiment.

St Giles has been the regimental home of the Camerons since the 1930s primarily as a result of the efforts of the Rev. Dr John Logan-Vencta, the Regiment's chaplain for 29 years.

St Giles responded to a recommendation from the Camerons in 2005 to revitalize our relationship. St Giles, for its part, continues to send care packages to all Camerons deployed abroad, usually for deployments of six to nine months. These demands reached a peak during the Afghanistan conflict when about 100 Camerons served. Today, the numbers of soldiers serving internationally are not large but St Giles continues to remember all who are.

This year we had a good attendance of Camerons at the St Giles Remembrance Service on November 10, The CO, LCol Gord Scharf, and Jeffery Hill, President of the Regimental Association, read lessons, trumpeter Cpl. Ann Gregory of the Governor General's Foot Guards and piper Cpl. Tim Read of the Regiment participated in the Act of Remembrance.

Unfortunately, because of retirements, the Pipes and Drums of the Camerons could not present their usual benefit concert for the Centretown Emergency Food Centre in December. WO Alan Clark has been appointed as the new PM for the Pipes and Drums. He was the PM in 2005 when the concerts were initiated. He is building up the strength of the band and, at the time of reporting, has 18 pipers rehearsing. However, their repertoire will not be built up for a concert in early 2020. Hopefully, they will be ready to perform at this very popular event at the usual time in December 2020.

Centretown Churches Social Action Committee (CCSAC)

In 2019, St Giles continued its strong support for CCSAC and, in particular, for the Centretown Emergency Food Centre (CEFC). While CCSAC has a broader mandate than the CEFC, most of CCSAC resources currently go to support the CEFC.

CCSAC recognizes that food centres are a response to the symptoms of poverty experienced by families and individuals who regularly find that housing costs and other non-discretionary expenses leave too little money for food. It has advocated for government action to address underlying issues of which the shortage of affordable housing is the most significant. The effects of provincial and municipal budget cuts and the impact they have in central Ottawa is an ongoing concern.

CCSAC has been looking at other social action initiatives that it might undertake that are not already being covered by government or other charitable organizations. The CEFC provides information to its clients about where they can go to get other kinds of help. In particular, Centre 507 which is a drop-in centre also located in the Centretown United Church building.

CCSAC meetings provide an opportunity to share information about social action and justice activities at the congregational level, e.g. "Out of the Cold" dinners at Knox Presbyterian and Southminster United, and sponsorship of refugees. At its AGM in March, the guest speaker was Willard Metzger, Executive Director of Citizens for Public Justice who gave an overview of the work of his organization.

The fourth annual "Walk for the Centre" organized by CCSAC took place on the first weekend in October and raised over \$20,000 money for the CEFC. St Giles provided total donations of \$1,165 in support of this event. The CEFC Management Committee once again organized food drives at local grocery stores. Food drives collect donations of food and money. Stan and Jean Currie have participated in the food drives at the Glebe Metro store which have been very successful.

In November, CCSAC held its annual Ecumenical Prayer Breakfast at Blessed Sacrament Church. This is a great opportunity for clergy and lay representatives to pray together for the people we serve and the work we are doing. CCSAC also sponsored the annual dinner in May to thank the volunteers.

The CEFC faces many challenges. Its current basement location lacks storage space and does not meet accessibility standards, but finding a better location is difficult. Church donations of food have diminished and the Centre is now doing more direct purchasing of food items. Despite good economic times and low unemployment, the client load has generally stayed about the same. The hope for a time when food centres will no longer be needed does not seem to be coming any closer.

The annual December pipes and drums concert by the Cameron Highlanders which has provided donations of money and food for the CEFC was postponed this year. However, as usual, 10% of St Giles takings from the Great Glebe Garage Sale went to the CEFC. Also, this year St Giles made a \$500 congregational donation to CCSAC as approved at the AGM.

St Giles volunteers in 2019 at the CEFC were Kaye Tate, Jean McNally, Nancy Lee, Roger White, Jean Currie and Stan Currie. I would like to thank them for their hard work, and all the others who have provided supporting donations.

FACCES Refugee Sponsorship Report

Since 2015, St Giles has been a part of the First Avenue Churches And Community Embracing (Refugee) Sponsorship. Since its inception this group has sponsored many and is currently aiding eight families and individuals who have come from countries as diverse as Sierra Leone, Burundi, Syria and Iraq. The organization has raised \$285,000 and disbursed \$264,000 since 2015. FACCES has announced that it is winding down its operations in June 2020. As part of its ongoing activities not just to provide for the settlement of refugees but also their integration into Canadian society, FACCES agreed to provide funds for one of the first families that the group settled to obtain Canadian Citizenship in 2020. When apprised of this development, the St. Giles Session voted last November to fund-raise towards the cost (\$1,460). At the time of writing, I am glad to announce that we have nearly met this goal. A special mention of thanks must go to Jane Pope who has often acted as St Giles sole representative to FACCES and has also made extensive efforts aiding with the settlement of refugees.

Finance and Maintenance Committee

Ongoing Activities

During 2019, the Committee was joined by Stuart Gentle and Sam Banda and their participation is most welcome. Continuing members are Isaac Ives, Jean Currie, Jean McNally, Don Tate (Treasurer) and Rob Brandon (chair).

Supporting the work of the Committee was our hard-working administrator Patricia Brush who keeps the books as well as being the point of contact for many activities at St Giles.

We have now had one year's cleaning experience with Jani Queen and our cleaners Nhu and Le, who are sister and brother, continue to provide us with good service.

In addition to the property report, Jean Currie reports at each meeting on the rentals activity and there is a separate report on this.

On the finance side, Don Tate and Pat Brush have done extensive work this year to ensure that our QuickBooks bookkeeping software provides financial information for the Treasurer's requirements and with significant work by them both, this has now been achieved.

For our green space maintenance, we have been using James Canton to do the grass cutting. With all the capital projects to manage, Rob has had to ask for some help from James's student gardeners in keeping on top of the weeding of the gardens.

2019 saw the continuation of capital projects as part of the three-year program to maintain the fabric of the Church using the investment returns from the capital realised from the sale of Logan-Vencta Hall.

Capital Expenditure Projects

The approved budget and actual expenditures are listed in the table "Capital Expenditures 2019". The actual expenditures, inclusive of HST, were \$194,830.15 compared to the approved budget of \$225,378.00. Hence, our Capital Spending was \$30,547.85 below budget. When we receive the total HST rebates (\$17,304.71), the net Capital Expenditures will be \$177,525.44 for the year.

One of the reasons for projects coming in under budget was that the repair and repainting of the Cameron window project component went well so the contingency allowance on this subproject did not have to be used. Another reason was that components of our shingle roofing and stonework were felt to be better postponed until 2020 in order to focus on fewer projects in 2019.

We were very lucky to have the services of Brian Driver of Heritage Carpentry & Joinery and Brian Eagle of Northern Art Glass working on this project. Using the interior scaffolding that we had used to replace the sanctuary lights, all the art glass was removed, inspected and stored while the wooden structure of the window was rebuilt. The exterior scaffolding was supplied by Scaffex and we were grateful for the tolerance of our neighbours to our reducing their parking spaces throughout the summer for a constant stream of contractor trucks.

Brian Driver completed the rebuild of the kitchen windows following the upgrade to the kitchen ovens and ventilation system. Brian also provided a new oak door for the First Avenue entrance while Active Automated

Doors installed an automatic opening system that gets constant use from members. The Church sign above the door was replaced with Session funds together with a new iron bracket made by Luc Ouellette of Heritage Carpentry & Joinery.

Another major project was the replacement of the lower metal roofs by Roofmaster as well as the south-facing shingled roof above the First Avenue entrance. There had to be some brickwork replaced as part of the metal roof rebuild and an opportunity was taken to increase the insulation under the new roof structure.

In the kitchen, the old gas stove and oven were replaced by a smaller gas range and an electric oven with a side-opening door. This new kitchen was used to its capacity during the successful Harvest Home dinner. The kitchen project was carried out under a tight budget by Ziad Deblines, of Deblines Landscaping and Construction, who also built a janitor's area with a suitable sink. In the kitchen, the sinks were retained but new taps were put in. Joseph Nehme, of J.A.N. Plumbing, also ran a water line to the existing drum humidifier so that water does not have to be transported up by bucket on a regular basis.

Most of the lighting in the church and the hall has been converted over to LED lighting. It proved possible to improve the lighting in the Sanctuary and Narthex by using LED bulbs provided by Buchanan Lighting and not replacing the fixtures. For the Hall, it was decided to abandon the existing wiring and Danco Electrical Services and Ring Electric installed new LED fixtures which have significantly improved the lighting levels which can be adjusted as required by switching on or off any line of lights.

At the end of 2019, some postponed electrical work was done to improve the lighting in the choir room/church office and also to install baseboard plugs in this room and also in the Minster's Study which had no baseboard plugs at all. Also, new carpet was installed at the First Avenue entrance along with additional lighting as this stairwell was very dark.

Projects for 2020

In 2020, the major project will be to work on the Bank Street face of the building in terms of rebuilding the remaining parapets as we did in 2017 for the Bank and First parapet. This will require scaffolding along the west-facing side of the Church facing Bank Street (the stonework repair around the Bank Street door was done in 2017). The whole project would be much easier if the City had buried the power lines along Bank Street when the underground services were being replaced. Dave Watson of MS Stoneworks has been talking with Ottawa Hydro to understand the cost and scheduling impact of protecting the hydro wires and the masons working on scaffolding close to the hydro wires.

There are two other components to this project. The first is the shingle replacement on the two small roofs that face west; the one on the southwest corner is in particularly bad shape. We also need to examine the condition of the large west window. When Brian Driver reviewed the condition of all the windows in 2017, the large window was reported to be in poor condition but much better than the Cameron window so the current opinion is that any wooden framework repairs can be made without removing the art glass. It may not be possible to do the stonework, the roof work, and the window work in this area all in one year. If so the stonework and roof work will proceed first and a detailed inspection of the window done to plan for work on this in 2021. A lot depends on what constraints Ottawa Hydro place on us.

We are working with the various contractors to develop expenditure estimates for the above and other anticipated 2020 capital projects. We will ask Session to arrange a congregational meeting when we have heard back from Ottawa Hydro and have definitive estimates and we will then seek approval to proceed. The objective will be to complete all of the exterior capital repairs by the end of 2021.

Lay Bible Study Group

We have been meeting every Friday morning, September to June, as a group of laypersons for many years. Our normal practice is to study books of the Old and New Testaments, chapter by chapter. In 2019, we studied: Colossians, 1 and 2 Thessalonians, the Gospel of John, and Ezekiel. We will study the books of Daniel, 1 and 2 Samuel in the first half of 2020. We were pleased to have the Rev. Dr Stephen Hayes conduct two seminars with us on Predestination and on the Trinity. New members are always welcome.

Music

As we look back at 2019, we had many different Ministers supply throughout this church year. The Church continues to search for a new Minister and since September the Choir and I have worked with many different Ministers from different Churches. We would like to thank them for their care and support as St Giles continues its spiritual journey.

On February 17, the Quodlibet Choir came to sing at St Giles again. Laura Brandon sings in this German Choir. We always feel like we are at a service in Europe. Thank you, Laura, for setting this up.

In September, Bob Fourney — for health reasons — left the Choir. Moira Hassell had a fall, so she is also unable to continue in the Choir and is taking a break. Sharon Haidenger joined us in March to help support the Soprano section, it is good to have another soprano in the choir.

Pat phoned me in July and said she had received an email saying someone had found our boxes of Anthems that had gone missing when I first arrived six years ago. "Would we like them back?" We are glad to have the many anthems back and the Choir is starting to learn new pieces which everyone will enjoy.

In July the Church was closed, but August we were open with soloist singing for those Sundays. Lawrence Cumming and Tracey Stabback sang a duet plus Laurel Ralston played her trumpet. I also took a Sunday off and Larry Kempffer played the organ.

A special thanks to the Choir for their continued support in their presence at Sunday service at St Giles.

We look forward with hope and joy to the New Year 2020.

Rental Coordinator

On Sundays, our morning worship service and coffee time is followed by the New Covenant Apostolic Church worship time in the Sanctuary. These good people also hold small group meetings at various times on other days. You have probably met some of them at our Harvest Home dinner or enjoyed their hot Jamaican lunch at our Bazaar. Two AA groups meet every Sunday evening in the Banquet Hall.

On Saturdays, there are three more AA meetings in the Banquet Hall. One of these groups has been meeting at

St Giles since 1967 and AA meets 52 weeks a year without fail! Twice a year Augustine College rents the Sanctuary for commencement and graduation ceremonies.

On weekdays, there is always something happening. We rent to two community choirs, The Ottawa Harmony Singers, directed by Patricia Brush, on Tuesdays, and the Ottawa Brahms Choir, directed by Christopher Askwith, on Mondays. A voice teacher uses the sanctuary for private classes and recitals. A trumpet player rehearses early in the morning so as not to disturb any neighbours. At different times various theatre groups use the Banquet Hall to rehearse. This year we hosted Kraken, Platypus, and Bear & Co. We also rented space to a film crew working in the area for a catered lunch. The Glebe Neighbourhood Activities Group uses our basement for kindergarten after-school programs every week.

Friday evenings are used several times each year for fundraising events. The Quakers and Pastors for Peace hold dinners (cooked off-site) with speakers and entertainment. The money raised goes to Cuba and Latin American countries. Good Morning Creative Arts Preschool also uses Friday evenings on occasion for end-of-term family parties.

This year we rented the Banquet Hall for an information evening about the Fifth Ave Court building plans. This drew in many neighbours to learn about the upcoming construction close to their homes. The Federal election also brought many local people into the building and paid rent to the church.

In total, our rentals meant \$20,900 for St Giles. We do not rent for commercial business events. Our non-profit and artistic groups are all people who improve the quality of life for people in the Glebe, in Ottawa, and around the world. We can feel good about sharing the beautiful building of St Giles.

Occasionally we don't even charge rent! In January 2019 we offered a warm-up venue at no cost for the Women's March. People walking from Parliament Hill to Lansdowne in January get very cold! I was there to welcome them in and even gave quick tours of the Sanctuary. Only the postal workers union building and St Giles Church responded to the plea for a warming centre along the route. A few people with small children or mobility problems simply started the march at St Giles and were happy to wait inside till the others arrived.
