# Minutes of the 2023 Annual Congregational Meeting (2023-02-26)

- Moved by Bob Brien / Jean McNally, that Isaac Ives be appointed as the secretary for the 2023 Annual Congregational Meeting. Carried.
- Moved by Isaac Ives / Bob Brien, that the Annual Meeting 2023 Agenda be approved as printed (or as amended). Carried.
- Moved by Isaac Ives / Rob Brandon, that the Minutes of the February 27, 2022 Annual Meeting be adopted as printed (or as amended). Carried.

- Moved by Isaac Ives / Stan Currie, that as recommended by the Session, the congregation of St. Giles accepts \$8400 as the 2023 Presbyterians Sharing Allocation. Carried.
- Based on the 2021 \$Base of \$192,891, the PCC has recommended that the Presbyterians Sharing Allocation for St. Giles in 2023 be set at \$19,289. In recent years, St. Giles had been accepting roughly 50% of the recommended amount, and that is just slightly below the average amount of Presbyterian congregations in Ottawa.
- Moved by Megan McEwen/Nancy Lee, that the congregation of St Giles makes a commitment to support the Presbyterian College for \_amount TBD in 2023. Rev. Dr. Roland De Vries, Principal of the Presbyterian College, wrote to the Session of St. Giles in November 2021, seeking financial support in the form of multi-year pledges for the ongoing ministry of the College—including training ministers through the core M.Div degree, continuing partnership with McGill through Montreal School of Theology, a new partnership with Laval University to train Francophone pastors, and developing lay and ordained leaders through the Leadership Centre. The Session of St. Giles is of the view that the Presbyterian College is worthy of our support, but would only be willing to recommend on a year to year basis. For the year 2022, the commitment of \$5,000 was recommended by the session and approved by the congregation. For the past year,

- \$2,000 was raised through donation by members of the congregation. The session has no recommendation for 2023.
- Laura Brandon moved that the amount to be pledged be deferred to another congregational meeting and be sent back to Session for consideration. Stan seconded the motion. Carried.
- Moved by Megan McEwen / Bob Brien, that Rob Brandon be appointed as Treasurer of St. Giles for 2023. Carried.
- Moved by Rob Brandon / Jean Currie, that Bob Brien, Don Tate, Jean McNally, Kate Ferguson, Meagan McEwen and Nancy Lee be appointed as Trustees of St. Giles for 2023. Carried.
- Moved by Rob Brandon /Jean Currie, that Isaac Ives be appointed as the Chair of Finance and Maintenance Committee. Carried.
- Moved by Rob Brandon /Bob Brien, that Jean Currie and Jeff Wilson be appointed as congregational Auditors for 2023. Carried.
- Motion by Bob Brien /Stuart Gentle, that the Trustees donate \$600 each to the Centretown Churches Social Action Committee and Gracefield Camp and Retreat Centre. Carried.
- Motion by Laura Brandon/Stan Currie to reconstitute the Mission Committee to recommend mission giving for the year in consultation with the Treasurer, Finance Maintenance Committee. Carried.
- Motion to adjourn Bob Harper/Bob Brien. Carried. The meeting closed with the Lord's Prayer at 1:58PM

# **Moderator's Report**

To Members and Adherents of St. Giles Presbyterian Church May the peace of Christ be with you.

What then is Apollos? What is Paul? Servants through whom you came to believe, as the Lord assigned to each. I planted, Apollos watered, but God gave the growth. So neither the one who plants nor the one who waters is anything, but only God who gives the growth. The one who plants and the one who waters have one purpose, and each will receive wages according to their own labor. For we are God's coworkers, working together; you are God's field, God's building.

(1 Corinthians 3:5-9)

In Paul's letter to the Corinthians, seeking to diffuse what appears to be a developing schism within the early church, the Apostle lays down the principle of partnership in service to God's people—that is 'we are God's coworkers, working together' to further God's kingdom for the glory of God. Some of us plant the seeds of faith, some of us water the field, but ultimately it is God through the Spirit that gives growth. It is a reminder to us not to rely on one's own ability, not to go at it alone, and not to think of oneself above others. For ultimately we are not just God's coworkers, we are also God's field, God's building. The Lord is building on top of us, and unto us the Kingdom of Heaven is actualized.

Partnership is the key word for St. Giles in 2023. We are a caring congregation in the heart of the Glebe. Though our worshiping community is small, through partnering with others, we have been able to put together a number of interesting events. With Bytown Community Church and Pastor Dan Chook-Reed, we jointly hosted the Pancake & Ash event of Pancakes Tuesday and Ash Wednesday, marking the beginning of Lent in 2023. Who would've known that having pancakes for supper could be so much fun, and the money raised went to support the Centretown Community Food Centre.

Working with Tom Sherwood, a retired United Church minister, we put together the event "A Meaningless Hour" on October 20, 2023. It is a solo theatre performance, where Tom recited the Book of Ecclesiastes in a style that is light hearted and contemporarily relevant. The money raised went to support the Multifaith Housing Initiative.

Through our long association with the Cameron Highlander Regiment, we resumed hosting the Christmas Concert with the Pipes and Drums of the Cameron, the Band of the Governor General's Foot Guards, and the Vocestra Chorus. It was a fabulous event, with full attendance, raising not in-substantial amount and two trunk-full of dry food for the Centretown Community Food Centre. For a small congregation, we really are 'punching above our weight' in serving the larger community of Ottawa in 2023.

The ministers of St. Giles, St. Andrew's and Knox Presbyterian Church have also been meeting and planning joint ministries for the three so-called downtown congregations. A number of initiatives have begun including 'Talk Film, Talk Faith' where people gather to watch a film and talk about how it dialogues with the Christian faith. We have also started a three way pulpit

exchange (on Dec. 31, 2023) with quite favourable responses, and plan to continue that in the near future.

As we reflect on the journey of this past year, we sadly have to say goodbye to Bob Fourney, Pauline Brown, Marilyn Brien, Helen Lister and Catherine Wilson. To us they are irreplaceable. Their faith are excellent examples to many. We will miss them terribly, and may they rest in God's peace.

During the past year, I have also been called on to serve in ministries outside of St. Giles. Other than Presbytery of Ottawa related ministries (which I see as regular part of my work), I have also been appointed to the Board of the Presbyterian College, and the Board of Gracefield Christian Camp. With blessings from the Session of St. Giles, I had also accompanied the Rev. Dr. Robert Faris, the Moderator of the 147 General Assembly of the Presbyterian Church in Canada (PCC), in his moderatorial mission trip to Taiwan, under the invitation of the Presbyterian Church in Taiwan (PCT). It is good to see how the Spirit of God is working in that island-nation (my place of birth). It is good to play the role of fostering closer ties between the two Presbyterian denominations. To be able to serve the wider church is a blessing in itself.

Finally, I want to thank you for receiving me as your minister, and continue to care and support my family in this calling.

# **St Giles Kirk Session Report 2023**

In 2023, the Session undertook many initiatives at St. Giles. In December, the Session resolved to amend our collection procedure to pre-pandemic method, a welcome return to normality. Also, in December St. Giles hosted the Cameron Highlanders of Ottawa's concert on behalf of the Centretown Community Food Centre, raising \$700 as well as a large amount of donated nonperishable food for the Centre.

Earlier in the autumn, St. Giles hosted another event Tom Sherwood's "A Meaningless Hour" with proceeds for the benefit of the Multifaith Housing Initiative.

In preparation for our centenary, Session voted to hire a student to catalogue our extensive archival collection with the intent of creating an easily accessible resource. We can report that we are pleased with the results and our thanks to Professor Walsh and Kari Valmestad for their efforts. The funds for this project were paid from the Memorial Fund.

An ongoing project is the use of our Sanctuary to display works from local artists, adding considerable visual attractiveness to our worship space.

Session continues to maintain communication with the Camerons Association and representation on the Centretown Churches Social Action Committee raising our visibility in the community.

Finally, thanks to the efforts of our minister St. Giles welcomed 4 new members in December.

I think I can say prayerfully that 2024 will be a great year for our community of St. Giles.

# **Activity Reports**

#### **Archival Committee**

St. Giles is blessed to have extensive holdings of records and photographs that cover the nearly 100 years of its existence. Part of these holdings were transferred to the Ottawa Archives in 1994. A committee under the leadership of Ken Lister was responsible for reviewing materials in the history room of the Logan-Vencta Hall. The objective was to have Archives staff organize and catalogue the items transferred to them.

In the latter part of 2022, the Archival Committee found that extensive historical material remained in the church. An inventory was taken and we found items that covered all time periods of our history and included all aspects of church life. Our church holdings probably exceeded those transferred to Ottawa Archives nearly 30 years ago. However, the St. Giles Inventory was dispersed and not organized. Organizing and cataloguing the church holdings was a major challenge.

The Committee met with Prof. John Walsh of Carleton's Public History Department and we engaged Kari Valmestad, in the second year of her MA studies. Kari spent the fall term with us. She organized, and catalogued all materials. Kari developed a descriptive catalogue together with detailed guide for accessing and adding. The physical inventory is organized in 25 boxes.

More recently, the Committee has focused on organizing and identifying a collection of pictures to complement Kari's work. Our near-term challenge will involve scanning about 350 representative pictures for storage and access.

The principal challenge for the Archival Committee, going forward, will involve integrating the historical materials at the church and the holdings already at Ottawa Archives. From our meetings with Archives staff, it is the committee's opinion that it would be best to organize the entire holding using Kari Valmestad's catalogue.

# Cameron Highlanders of Ottawa (Duke of Edinburgh's Own)

In 2023, the Cameron Highlanders continued their long-standing association with St. Giles. They consider St. Giles to be their regimental church. Don Tate normally represents the congregation at the monthly Regimental Association meetings, maintaining the ongoing link with the regiment.

We were pleased to have the Camerons participate in our annual Remembrance Service. Our scripture readers were LCol Gord Scharf, Commanding Officer of the Regiment, and Jeffery Hill, President of the Regimental Association. Bugler Sgt. Peter Limeburner and piper Sgt. Brennan Pinkerton-Kock participated in the Act of Remembrance.

The highlight of the 2023 Camerons' participation with St. Giles was the resumption of the Christmas Concerts. On December 1, we had our first concert since the Covid pandemic. Pipe Major Sgt. Brennan Pinkerton-Kock, and Drum Major Sgt. Peter Limeburner, of the Pipes and

Drums, were responsible for organizing an excellent evening. The Pipe Band was joined this year by: The Vocestra Chorus, and a Saxophone quintette from the Governor General's Foot Guards. Together they provided outstanding entertainment. The event was a benefit concert for the Centretown Community Food Centre. The audience was generous, supplying a good quantity of non-perishable food as well as cash donations.

As is our custom, St. Giles sends care packages to Cameron soldiers that are deployed. The soldiers enjoy, particularly, receiving home baking. Bakers from our congregation supplied much-appreciated, generous quantities to three deployments in 2023.

# Centretown Churches Social Action Committee (CCSAC) and Centretown Community Food Centre (CEFC)

In 2023, CCSAC has focused on assisting and advocating for the people in Central Ottawa who are living in poverty. As the pandemic has eased somewhat, inflation has risen with a serious rise in the cost of food and housing. CCSAC focuses on activities that meet core needs of the vulnerable and are not covered by other organizations. It continues its long-term role of helping to address food insecurity which became a more serious problem in 2023 as a food prices rose sharply as a significant increase in inflation also affected the cost of housing and other basic living expenses. CCSAC also ensures that the collective voice of its 22 member churches is heard on various social justice and poverty-related issues.

2023 was a year of significant of change for the Food Centre. The first change was to replace the word "emergency" in its name which made sense in early years when it was seen as short-term need. The word, "community" seemed more appropriate as food insecurity has become an ongoing concern with no end in sight.

For several years, the Food Centre had been looking for a larger space in order to serve its clients better. Finally, the CCFC was offered a space at the City Community Hub on Catherine Street. This space was much larger, accessible and had a place for clients to wait indoors. It also facilitated a change to a shopping model where a volunteer accompanies the client around the area where food items are displayed on shelves and the clients gets to choose the items they want within limits on the quantities of each item. The Food Centre opened at its new location at the beginning of May.

Since the beginning of pandemic, St. Giles has not provided any volunteers for the Food Centre. This may change as the need for volunteers has remained in the new location. We have participated in the annual Walk for the Centre which raised almost \$40,000 for the CCFC in 2023 . St. Giles donations were slightly less than in 2022. The St. Giles Walkers this year were Nick Lussier, Katie Gratton, Paul Wu, Jean and Stan Currie. Thanks to all those who donated in support of the Walkathon.

One of the useful activities of CCSAC is providing information on various projects and activities that are of interest to its supporters. It has a website, a Facebook page and also produces a newsletter which is distributed several times per year (4 in 2023).

CCSAC continues to hold most of its meetings on Zoom. It initiated a Speaker series in 2021 as part of its regular meetings. This is convenient for speakers who prepare information which can be displayed using the share-screen capability of Zoom. These presentations provide a wealth of information which is valuable knowledge about the challenges in our community and how they are being addressed by various charitable endeavors which are of interest to CCSAC and provide help and support to those in need in Central Ottawa.

#### St. Giles Children's Sunday School (CSS)

Annual Report 2023

We are thankful that God is continuing to work in the lives of our Sunday School students and their families. CSS leadership has continued with the faithful service of teachers, willing volunteers and helpers including Daisy Tsai, Vivian Su, Mary Lloyd, Kaye Tate and Rob Brandon.

In January we continued with the lectionary based curriculum "Feasting on the Word". We began with the Baptism of Jesus ("Meant for Ministry'). We studied the Apostle Paul's ministry and considered Jesus' early teachings in the Beatitudes. Lessons in the Old Testament included stories of the what happened in the Garden of Eden, and in the lives of Moses, Abraham and David. Before Easter time we looked at the story of Lazarus and later how Jesus entered Jerusalem and contrasting this with the events of Holy Week. From there we moved in to the story of the Resurrection of Jesus and how subsequently appeared to Thomas and later to followers on the Road to Emmaus. For Sunday School closing we participated in the service singing for the congregation praising God and followed by a lunch at MacDonald's. It was nice to have personal contact with some and written communication with all of the children's families in the summer months. It seemed they were all active enjoying various camps and as well as travels far and wide!

Sunday School resumed in September. We changed curricula due to availability of the current material in Canada and so began using the "Sparkhouse Lectionary" curriculum. First we learned of the story of Joseph and his relationship with his brothers. We moved into the New Testament and studied Jesus' parables as told in the last books of Matthew Chapters 22 -25. We concluded the year with the story of the angels visit to Mary and to Joseph before Jesus was born followed by the story of Jesus' birth.

Indeed the whole congregation is included in supporting our students and their families who bring their children to church. We are thankful to church members who affirm the CSS from week to week during the service and after church coffee time and in other activities where the children are participants. We appreciate the church's generosity in providing a table tennis setup for an after Sunday school activity.

#### **Finance and Maintenance Committee**

For 2023 Rob Brandon was Treasurer and Isaac Ives continued as Chair and kept the Committee's minutes. Members were Stuart Gentle, Jean Currie, Jean McNally and Nick Lussier. Roger White stepped down from the Committee in 2023 and Troy Lutz joined. Isaac and Rob are grateful to all who are, or have, served on the Committee.

### Staffing

At the beginning of the year a search was carried out for an administrative assistant to replace Pat Brush who had indicated she wished to retire in June. We were lucky to find Rosemary Bann who worked together with Pat to get familiar with St Giles's bookkeeping and procedures. Pat left the Church's employment at the beginning of June with a send-off celebration from the congregation. Rose has worked hard this year to get familiar with all of the Church's procedures. Towards the end of the year Jean Currie indicated that she wished to step down as the sole person responsible for rentals. Rob Brandon agreed to take on the contracting responsibilities with Rose being responsible for keeping the rental calendar. Jean will still be able to provide advice and also in some cases letting people into and out of the building. As the office computer is old and overheats a replacement was ordered from PC Perfect, a computer company located nearby on Bank Street. We will be replacing the QuickBooks software with a version better suited to nonprofit organizations such as St Giles. The transition will be done on the new computer with the new software in Q2 of 2024.

### **North Roof Replacement**

When the major capital renovation project concluded in 2021 the main church roofs that faced north were not re shingled as there was still life in the old shingles. However, in early 2023 it was observed that the roof needed work. Two contractor quotations were obtained, one from Roofmaster who had done all the previous roofing work satisfactorily and another quote from Sanderson Roofing, an old and established roofing company. The committee decided to accept

the Sanderson quotation of \$49,516 ex HST. The work was completed to our satisfaction by the end of summer at a slightly lower cost of \$47,716 as the supplier had discontinued the extra heavy-duty shingles originally specified. An additional project was the installation of ice guards on the First Avenue door roof. With the completion of this project and baring any unexpected events, it is felt that the majority of major building work for St Giles has been completed.

#### **Additional projects**

During 2023, painting of the wall alongside the lift ramp was done by AA members and another member painted the step railings on Bank Street. The florescent lighting in the kitchen was replaced by LED lighting. Projects for next year likely will include the installation of a plumbing backflow preventer mandated by the City of Ottawa at a cost of \$7,500 and repairs of the concrete steps on Bank Street.

#### **Finances**

St Giles was \$8,186.49 short on its budget target of \$94,500 to the operating account and \$6,707 short on its Total Income budget of \$123,500 for the year. On the expense side of the ledger expenses were \$3,204.47 higher than the budgeted amount of \$231,439. Details are available in the Report Tables. The 2023 operating deficit which is made up by a transfer from the Trustees was \$117,552.94. The roof replacement cost of \$47,716 was also covered by a transfer from Trustees as this is considered a major capital cost and not part of the operating account.

In 2022, members of St. Giles undertook the Community Sponsorship of the Family of Bonaventure Bigirimvano: Gadi, Celine and their five children. Bonaventure has been pursuing this goal steadily and admirably. Our Minister, Rev. Wu has been assisting by communicating with the appropriate authorities. However, due to the many applications there have been delays in processing the claim, at the time of writing the date of this processing will be in May of 2024. As ever, we pray for the family's safe passage to Canada.

#### **Report on Rentals**

St. Giles Church is happy to share our beautiful building with other groups needing space.

On Sundays, we host two small churches. The New Covenant Apostolic Church worships upstairs in the Sanctuary while we are enjoying coffee time downstairs. Then later on Sunday afternoon the Bytown Community Church uses the Sanctuary and also the basement space. Dan Reid is the minister of this start-up congregation.

We also host as many as six AA groups every week. Some are for men or women only, while some are for newcomers. They generally meet in the lower hall, but are very flexible if we need the space for a special event. We can almost always offer them space in the Sanctuary at their usual time.

In addition to these regulars, we host a variety of other people. In 2023, this included music teachers needing space to hold recitals by their students. Our piano and acoustics were appreciated by all.

We provided rehearsal space for a theatre group who travel world-wide to act alongside a symphony orchestra. A wonderful way to make younger people comfortable and involved as they encounter classical music.

In the spring we provided space for catered meals and a place to rest for the cast and crew of a movie company. They were making a Christmas movie and also asked us if they could film outside St. Giles.

They spread artificial snow on Bank St. and First Ave. everyone walking outside laughed to see the very realistic snow in late spring.

Other small rentals included a condominium board meeting and a place for local community centre folk to make many large posters for a meeting.

In 2023, St. Giles raised a total of \$18,585 from rentals. This amount is less than we had hoped. That is mainly because we hoped to get a significant amount from the Glebe Neighbourhood Activities Group.

Generally we had After School and Summer Programs for children run by the Glebe Community Centre but this year they did not use the local churches in the same way. Instead I believe they hosted most such events at the Community Centre.

We are also thankful to have Aditi Magdalena join us for Sunday services. Aditi plays the violin and viola. When she is with us she plays the prelude and postlude and creates parts to play with the hymns. Aditi is also a trained, gifted singer. Katie and Aditi have given wonderful leadership at our Taizé services. We also thank Rev. Paul Wu for his interest and participation in the choir.

Now that the worry - and fear - of COVID is easing we hope to have more guest instrumentalists - perhaps students - join in our worship.

The organ at St. Giles Church is in good shape and is well maintained. We are blessed to have a dedicated and very capable organ technician in this area. Sylvain Brisson of Orgues Brisson in Embrun tunes and checks the organ regularly and will respond quickly to other problems that might arise. Thank-you Sylvain!

We have continued to have Katie sing hymns from the front of the church and the choir members sing from the congregation to encourage everyone to sing. Please open your mouths and sing out!

The choir and I always keep the door open to new singers. Experienced, trained singers are good. Also remember - choir is where you learn to sing. Please join us on Thursday evenings and Sunday mornings!

#### **Worship Committee Annual Report 2023**

2023 was a very good year which included some challenges and new endeavors. Our minister Paul Wu and our music director Heather Rice have continued to plan and deliver excellent worship services.

Our vocalist, Katie Gratton, remains a valuable asset as her strong and enthusiastic singing makes singing a key feature that encourages the congregation to sing and attracts newcomers. This is a solid base as we work toward revitalizing St. Giles.

The easing of COVID concerns has led to relaxing rules and encouraging more in-person attendance. This has strengthened in-person participation and reduced the number of people using Zoom. The most recent change was to return to the traditional method of doing offering by having ushers pass the offering plates.

The Worship Committee recommended that we continue the practice of giving access to our worship service for people who couldn't attend in person by allowing livestream access by Zoom, by teleconference and video recording of the services posted on YouTube so that people can view a service that they missed, and Session agreed. The virtual Passing of the Peace acknowledges everyone who is joining the service in-person or virtually and is one form of welcoming newcomers. It also encourages newcomers to stay for coffee time after where we get to know the newcomers and they begin to know some of us.

Rob Brandon continues as the head of our technical team and is essential to solving problems and seeking improvements. Our back-up is sometimes stretched when Rob is away. Glitches do happen from time to time and although the technical infrastructure is not part of the service, it is the means of including those who are not present in-person.

The practice of celebrating Holy Communion six times per year began in 2022 and has become the new standard. The six times are February, Easter (usually in April), June, August (in a shared summer service), October (Worldwide Communion Sunday) and December during Advent. Having the Sunday School teachers and children rejoin the congregation to participate has become the norm.

Once again, St Giles had a Good Friday service which was shared with the Bytown Community Church. We initiated having an Ash Wednesday service to mark the beginning of Lent and shared with the Bytown Community Church. We also had two Taizé services, one in the Spring and one in the Fall, again sharing with the Bytown Community Church

On PWS&D Sunday in February, Paul showed some slides illustrating PWS&D projects in various countries. The share screen feature in Zoom allowed the slides to be shown on the large screen in the sanctuary as well as to those connected by Zoom.

Heather continued to work on establishing a small choir with practices now held on Thursdays at 5:30 pm which seemed the best time for the current choir members. Recently, the choir

sings a piece together as the prelude from time to time, and then joins the congregation to help them sing the hymns.

Technical support team includes Stu Gentle has been helping regularly, Nick Lussier also helps when needed and Justin Wu has occasionally been recruited when Rob is absent.

In April, Paul was invited to join a group accompanying the PCC Moderator on trip to meet with the Presbyterian Church in Taiwan. In his absence, we had two supply preachers, Ryan Farrell who is involved in campus ministry at Ottawa U. and Daniel Crepaud who works at Harvest House, a facility trying to help people struggling with addiction. Paul also arranged for Shawn Seaman, the recently retired minister of Trinity Presbyterian in Carp to be our anniversary speaker. All three of these speakers were well received. Paul subsequently gave a very informative presentation on his Taiwan trip as part of a worship service.

The virtual Passing of the Peace is an important part of our Sunday services. Paul continues to do amazingly well at greeting people by name, and connecting with newcomers. In fact, newcomers have become a noticeable proportion of regular attendees at worship services. Since its resumption in March, our in-person coffee time has helped enormously in integrating them into the life of the congregation.

Paul has been monitoring church attendance. The shared summer services at St. Giles were very well attended. The best attended Sunday service of the year was Remembrance Sunday. In 2023, Christmas Eve fell on the fourth Sunday of Advent. The Worship Committee discussed options of doing two services or only one service. If only one service, then it should be the traditional Christmas Eve service which is always well-attended. It was noted that this raised a question about the Advent candle lighting and the Advent liturgy. The Session decided to go with two services and so attendance was split between the two services but in the end probably increased the overall attendance.

The largest service of the year was the Pauline Brown memorial service on Saturday, June 10 with a large in-person attendance and a very large number connecting by Zoom. St. Giles was Pauline's home church in Ottawa and she remained on our roll as allowed for missionaries. Although Pauline retired, she decided to stay in India where she had lived most of her life. Paul Wu led the service and three speakers, talked about Pauline. A catered reception, provided by family of Pauline in Ottawa, was held in the banquet hall after the service.

A pulpit exchange among the three downtown Presbyterian congregations, took place on the last Sunday of the year, Karen Dimock, the minister at St. Andrews .preached at St. Giles, Paul Wu preached at Knox and Jim Pot, the minister at Knox preached at St. Andrews. This worked very well and may be repeated in the future.

Paul's sermons continue to be excellent and often contain content that is new, even to regular churchgoers. Copies of the sermons are available and helpful to people with hearing difficulties.

His children's stories are usually very good and are appreciated by adults as much as the children. The attendance of the children has been very good. The team of Daisy Tsai and Mary Lloyd have been doing a great job and the children are very faithful in attending.

The Worship Committee has continued meet about once every six weeks.. The members of the Worship Committee in 2023 at the beginning of the year were Paul Wu, Rob Brandon, Heather Rice, Pat Brush and Stan Currie. When Rosemary Bann was hired as church administrator, she attended committee meetings with Pat until the end of her training period. Pat retired in June 2023 and then Rose replaced her as a committee member.
